 - e. Students Assistance Company, located at 244 S. Randall Road, Suite 111, Elgin, Illinois.
 - f. American Education Service, located at 4717 Hondo Pass 3B Box 125, El Paso, Texas. (*NOTE: American Education Service is off limits, but not Postal Outlets Plus, a separate business located at this address).
 - g. International Press Acceptance Corporation, located at 4717 Hondo Pass 3B Box 125, El Paso, Texas 79904. (*NOTE: International Press Acceptance Corporation is off limits but not Postal Outlets Plus, a separate business located at this address.)
 - h. Geronimo's Bar and Grill, located 3031 Paseo Triunfo de la Republica y Monumental, Juarez, Mexico.
 - i. Max-Fim Restaurant, located at intersection of Monumental and Paseo Triunfo de la Republica, Juarez, Mexico.
 - j. United Educational Corporation, located at 188 Industrial Drive, Suite 234, Elmhurst, Illinois.
